Bruce reminded Basil, Brett and Jeremy that they had agreed at the June 25 meeting to develop a rough design and present it to Norm Berner, City of Little Rock Parks and Recreation Dept.

General Membership Meetings

Members discussed whether or not to conduct general membership meetings in an indoor setting. It was the <u>consensus</u> of the Board to conduct an outdoor mountain bike ride with some trail work and a group picnic in lieu of indoor meetings. It was suggested that a pavilion at Burns Park would be suitable for a Saturday morning or Sunday afternoon event.

Bruce reminded Board members that CATA would need to obtain IMBA-required insurance coverage soon.

Mike Mitchell discussed forming a group of juniors that could be called "CATA Kids" for the purposes of teaching stewardship, participating in trail maintenance activities, and learning safe mountain biking.
